

My Energy Improvement Plan Registration

Welcome to the Municipality of the District of Guysborough's My Energy Improvement Plan, administered by Efficiency Nova Scotia. The purpose of the application is to provide pre-qualification to help you obtain financing from the Municipality to make eligible energy efficiency upgrades to your property. For fast pre-qualification, please complete the following form and submit it to the Municipality. Further instruction on how to submit this application is found below.

What's Next?

Upon receipt of your completed registration, the Municipality and Efficiency Nova Scotia will review your application to determine your property's eligibility based on the following:

- Verification of property ownership
- Status of your property tax and utility bill payments
- Mortgage lender consent (if applicable)

Following the completion of the review, if your property qualifies, the Program Manager will provide you with a Notice to Proceed letter that identifies:

- A file reference number for tracking your application as you proceed
- Information for contacting a Certified Energy Advisor to arrange for an initial Home Energy Assessment. This cost is eligible for reimbursement under this Program (all improvements must be completed, along with a final Home Energy Assessment). All Efficiency Nova Scotia rebates (if applicable) will be assigned to the Municipality to deduct from the total project costs.

Please note: after you have completed an Initial Home Energy Assessment, the Municipality and Efficiency Nova Scotia will review all intended upgrades to ensure that your home meets the energy savings criteria. A savings-to-investment ratio of one (1) or greater must be achieved. This means that the estimated annual energy savings (\$) must be equal to or greater than the estimated annual payments to the Municipality.
